Rules of Participation

- To reserve a space, please submit a signed application and participation fee (non-refundable) to the First Lyman church office before October 4th. Late applications or payment will be subject to a \$10 late fee.
 - 10' x 10' space = \$35
 - 10' x 20' space = \$55
 - Spaces will be assigned by the event planners.
- Tables are available on a first-come, first-served basis for an additional \$10 fee.
- Electricity can be run to your booth for an additional \$5 fee.
- The event will take place in the church parking lot (by Groce Rd). In the event of rain, the event may be moved indoors to the Family Life Center.
- Limited parking will be available. Instructions will be provided to exhibitors.
- The event begins at 9AM on November 9th. Exhibitors may begin set-up at 6:30AM and must stay until 4PM, unless otherwise determined by the event committee.
- Signs within the booth are permitted and must be of an appropriate nature. Loud or offensive exhibits are not permitted. FBC Lyman reserves the right to request the removal of inappropriate displays.
- Smoking is not permitted on church property.

Terms and Conditions
